

## **KBA - TITLE I PARENT INVOLVEMENT**

Pursuant to federal law, the District and the parents of students participating in Title I District programs have jointly developed the following parent involvement policy that shall be incorporated into the District's Title I plan. The term "parent," as used in this policy, is defined as a parent or guardian of a child receiving Title I services or attending a Title I school-wide program.

### **INVOLVEMENT WITH TITLE I PLANNING**

The District will hold an annual meeting of the Title I Community-Parent Advisory Council ("C-PAC") for the purpose of discussing the Title I program plan. C-PAC is composed of parent representatives from Title I schools, community members, Title I staff and principals. C-PAC shall provide input to the program plan, review implementation of the plan, discuss how Title I funds allotted for parent involvement activities shall be used, and provide suggestions for improvement. The meeting shall be open to all parents of students in Title I programs, as well as school staff, principals, and other interested persons.

### **INVOLVEMENT IN THE PROCESS OF SCHOOL REVIEW AND IMPROVEMENT**

In

Provision of materials and training to help parents work more effectively with their children and with the school;

Provision of materials and training to help Title I and school staff work more effectively with parents;

Assistance with translation of informational materials and programs for parents;  
and

Fiscal assistance in carrying out activities.

The District will provide to parents, as appropriate, information to help them understand the state's academic content and achievement standards, state and local academic assessments, the requirements of Title I, how to monitor students' academic progress and how to work with school staff to improve the achievement of students. The information may be provided in written form such as pamphlets, through video presentations, during the Title I parent orientation meeting, parent teacher conferences, or workshoecwG2(m)-3(i)6encreo
